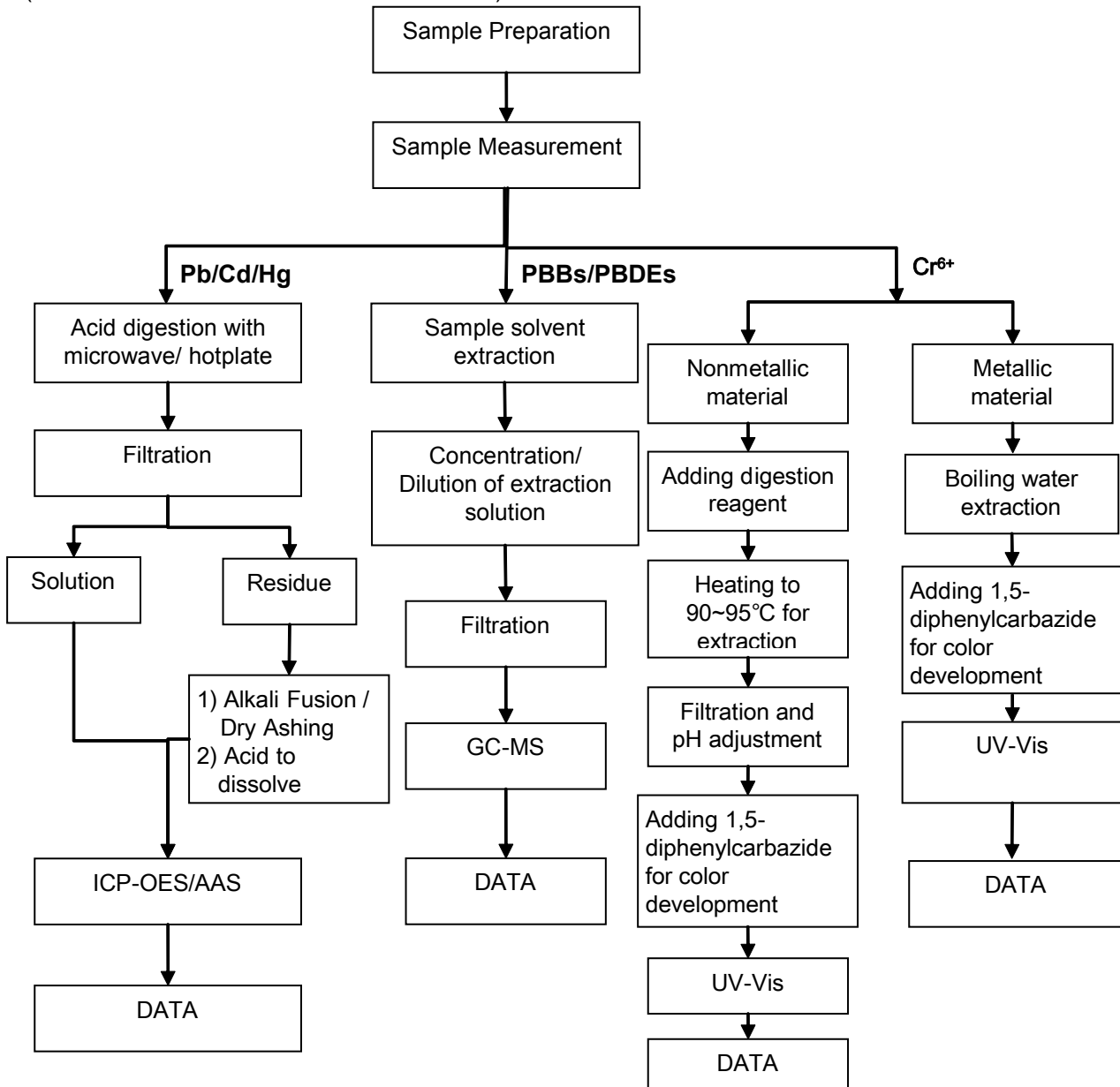

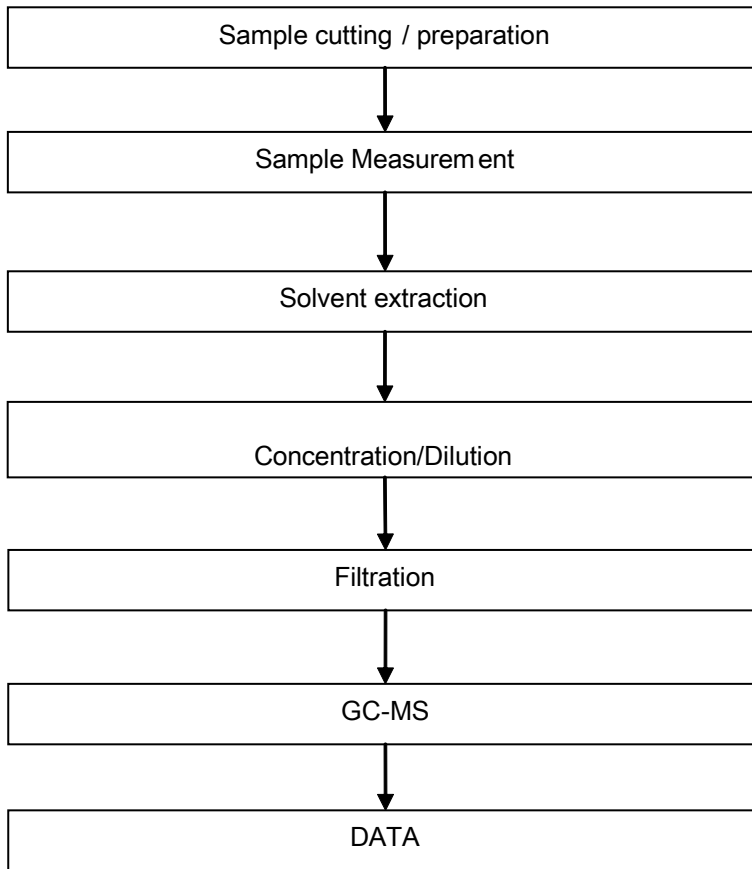

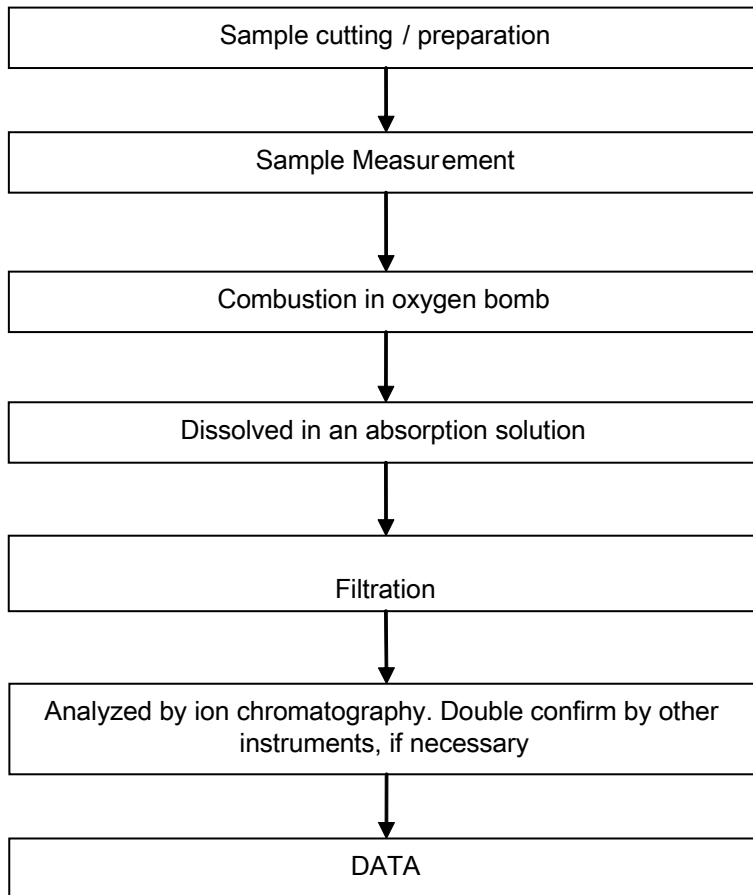

Halogen Testing Flow Chart

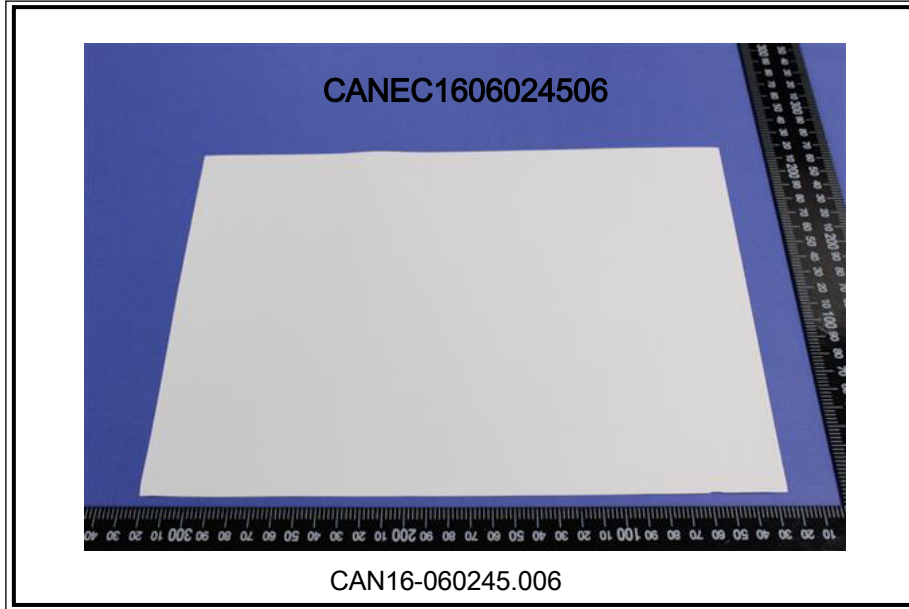
